**ACTION:** Leo Waters made a motion to approve the DBE & Procurement Committee minutes of May 31, 2012. The motion was seconded by Willie McDonald and approved unanimously by the committee.

Larry Atema was asked to review the Jefferson Street United Merchants Partnership contract.


**ACTION:** Leo Waters made a motion recommending to the full Authority that the contract with the Jefferson Street United Merchants Partnership (JUMP) be amended to extend the agreement until April 30, 2013 at a monthly fee not to exceed \$12,500 per month and authorizing Mr. Dickens to execute the extension and take any actions necessary or appropriate to formalize and finalize that extension. The motion was seconded by Willie McDonald and approved unanimously by the committee.
