**ACTION:** Francis Guess made a motion to approve the DBE & Procurement Committee minutes of September 27, 2012 and October 25, 2012. The motion was seconded by Leo Waters and approved unanimously by the committee.

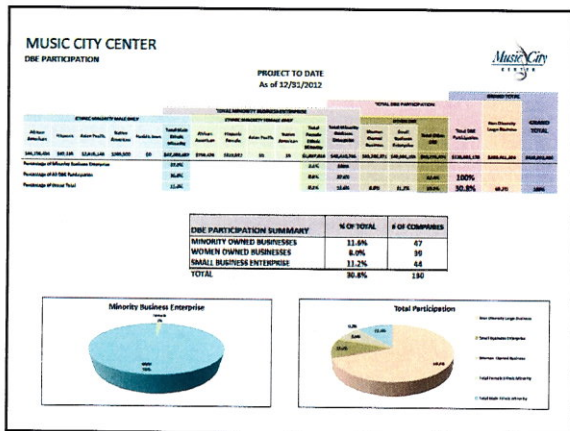
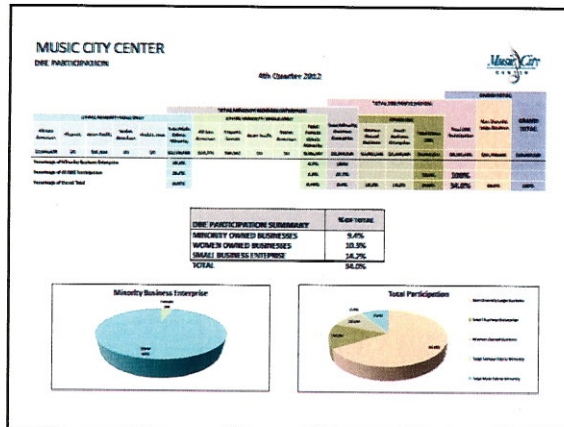
